# 5. Regional Interest Groups

VPIAG received a report on existing Regional Interest Groups (RIGs) and discussed the following points:

- i. The effectiveness of existing RIGs;
- ii. Feasibility of establishing further Groups;
- iii. Means of enhancing effective communication;

iv. Ownership of current and future RIGs and SYMPA mail-base lists.

# 6. Update on incoming and outgoing student participation in mobility programmes for 2017/18

VPIAG received an update about incoming and outgoing student participation in mobility programmes based on the number of applications received so far from associate students for entry in autumn 2017, and numbers of students on outgoing mobility through Erasmus+ and International Exchange.

# 7. International Student Recruitment Update

VPIAG noted that PGT recruitment looked promising so far with a higher number of firm acceptances of EU and international students than in the previous year. While the recruitment of UG students had decreased in certain schools, it was expected that this would be compensated through the clearing process.

# 8. ALSA Report (Academic Lead for Study Abroad)

The report focused both on visits undertaken to the US to meet new partner institutions interested in sending students to QMUL and also on discussions with QMUL School Study Abroad co-ordinators aimed at identifying ways of attracting associate students.

# 9. Update on partnership applications

The Group received an update on partnership applications and noted that 100 applicants for articulation and progression arrangements had been received from a more diverse range of partners than in previous years.

## 10. Outward Mobility Report

VPIAG received an update from the Academic Lead Outward Mobility. The report covered the following points:

- i. Four-Year Degree programmes with a year abroad;
- ii. Bursaries and Widening Participation;
- iii. Study Abroad Coordinators;
- iv. Capturing information.
