Regulatory/statutory reference points	<ul style="list-style-type: none"> • <i>The Chair [of the SEB] shall be an experienced senior member of academic staff, but not a serving Head of School or Institute, or a Faculty Dean for Taught Programmes, or an honorary member of academic staff. Programme directors shall not normally act as Chairs for SEBs where their programmes are under consideration. A Deputy Chair shall fulfil the duties of the Chair in the Chair's absence. Chairs and Deputy Chairs shall be appointed by Senate, or its delegated authority. (Academic Regulations 2013-14, 1.37)</i> • <i>The membership of a Degree Examination Board shall be as follows:</i> <ul style="list-style-type: none"> <i>i. a Chair, appointed to the role by Senate, or its delegated authority (Academic Regulations 2013-14, 1.43)</i>
Strategy and risk	Examination boards, and their Chairs and Deputy Chairs, have significant responsibilities in maintaining QM's academic standards with regards to assessment. Senate delegates its authority to these bodies. It is important that those appointed to lead these boards are appointed through the correct procedures, and that Senate is satisfied that those appointed are appropriate candidates.

Examination Board Chairs 2013/14

Preliminary

Senate delegates authority to examination boards for the consideration of students' achievement, progression and awards, and other related matters. There are two levels of examination board; Degree Examination Boards, and Subject Examination Boards. The Chairs and Deputy Chairs of both types of examination boards are appointed by Senate, or its delegated authority. In the case of Subject Examination Board Chairs and Deputy Chairs, Senate's delegated authority is the relevant Head of School/Institute. In the case of Degree Examination Boards, the delegated authority is the Vice Principal (Teaching and Learning), who will approve, or otherwise, recommendations from the Faculty Dean for Taught Programmes. Chairs and Deputy Chairs are appointed for three year terms, with the possibility of an extension for a second term.

This paper lists the current Chairs and Deputy Chairs of the Degree and Subject Examination Boards. Senate is asked to **note** and **endorse** the appointments.
