1. The Research Degrees Examinations and Awards Board meets monthly. The membership was revised at the September 2013 meeting and now comprises:

Appointment of Examiners

2. The Board considers nominations for internal and external examiners for research degrees. From September 2013 to November 2013 the Board considered examiner nominations for 69 candidates for research degrees. 4 nominations (5.8%) were rejected or deferred pending receipt of further information.

3. The Board considers outcomes of research degree examinations and views all examiners' reports. From September 2013 to November 2013 the Board considered the outcomes of 58 examinations:

Quality assurance processes for research degrees.** The Board has reviewed and developed a project plan from ARCS on developing quality assurance processes for research degrees during 2013-14, designed to ensure that QM is meeting all the expectations in the relevant chapters of the QAA's new Quality Code.
- 6. Report on research degree appeals and complaints 2012-13.** The Board reviewed a report from the appeals team on appeals and complaints submitted by research degree students in 2012-13. The Board was pleased to note that, against the overall number of PGRs registered, the numbers of complaints and appeals was very small (<1%).

- To consider requests for interruptions of study and extensions to the maximum registration period/writing-up period;
- To monitor compliance with the Regulations and Code of Practice for Research Degree Programmes within Schools and Institutes;
- To have oversight of the admission of students to research degree programmes.
