3. The Board considers new partnership proposals with both UK and international partners and evaluates any risk involved. From December 2013 to March 2014 EPB has considered 10 new collaborative arrangements.

## Policies and procedures

- 4. EPB has approved the process both for renewal of current Erasmus agreements and for new agreements under the Erasmus+ Programme. Erasmus +inter-institutional agreements now fall under the collaborative provision framework and will be approved by EPB.
- 5. EPB has considered distance learning TNE models used by SEECS and by CCLS and discussed ways to co-ordinate other possible models and initiatives across QML.

#### **National consultation**

6. EPB has considered and approved QML responses to the QAA consultation on Strengthening the quality assurance of UK transnational education' Following analysis of the consultation responses, QAA will publish an overview of the planned process for quality assurance of UK TNE by 31 May 2014. QML's TNE activity will be subjected to the review methodology adopted after the consultation.

# International Issues

7. EPB has discussed a paper on *Maintaining International Fee Income through TNE Expansion* and considered a number of potential opportunities for QML to develop its TNE provision in order to increase its international student recruitment.
