EXECUTIVE SUMMARY

Terms of Reference and Membership

1. Board membership consists of:

Chair: Vice Principal International Deans for Taught Programmes Chief Strategy Officer; Special Advisor to the Principal on China Operations; Deans for Research; Academic Registrar and Secretary to Council (or nominee); Director of Marketing and Communications (or nominee); Student representative.

- 2. Revised Terms of Reference (TORs) and Board Membership composition were approved by Senate at its meeting in December 2014.
- 3. The Partnerships Board meets monthly. During the reporting period, PB has held two meetings.

Consideration of new partnership proposals and renewals

4. The Board considers new partnership proposals with both UK and international partners and evaluates any risk involved. During the reporting period, PB has considered 11 new collaborative arrangements.

 - Proposal to introduce a revised policy on joint and double degrees in Queen Mary Collaborative Provision Framework (QMCPF): discussion paper relating to the potential for QMUL to offer joint awards. Following PB comments, the proposal will be updated and will be submitted to Senate in the next academic year.
 - Arrangements for the Termination of Collaborative Partnerships: proposal to review and enhance the current termination procedures.
 - Agreements with overseas sponsors/governments: new process of partner approval in the area of co-funding.
