EXECUTIVE SUMMARY

MEETING HELD ON 9 FEBRUARY 2015

1. Summary

This report summarises the main areas of discussion of the Advisory Group to the Vice-Principal (Public Engagement and Student Enterprise) at the meeting held on 9 February 2015. For a full set of notes please contact the Secretary, Katherine Bevan k.bevan@gmul.ac.uk

2. Approval of Terms of Reference and Membership

This was the first meeting of this Group, with one further meeting scheduled for 2014/15. From 2015/16 onwards, the Group will meet three times per academic year (once per semester). The Group's terms of reference and membership for 2014-15 is provided in Annex A and will be further revised at the start of 2015/16.

3. Report from the Vice Principal for Public Engagement and Student Enterprise

The Vice-Principal reported that a Public Engagement Strategy was to be developed in support of the main College Strategy document, and that there was clear evidence of high impact scores in the Research Excellence Framework exercise due to the research-led public engagement work carried out across the College. The Vice-Principal also noted that positive feedback had been received from Research Councils UK (RCUK) due to College activities funded by the RCUK Catalyst Grant.

4. Faculty Report on Impact and Public Engagement – School of Medicine and Dentistry

Dr Rob Bennett gave an oral report on Impact and Public Engagement activities within the School of Medicine and Dentistry. The report was focussed on activities within the Centre of the Cell and the Pathology Museum. A number of other areas and initiatives e.g. QProjects, the Centre for Psychiatry, and the Dental Outreach Centre were also mentioned.

5. Centre for Public Engagement

Copies of the two annual reports that QMUL had prepared for RCUK were circulated, along with recent feedback received from RCUK. Work was in progress to prepare for Planning and Accountability Round (PAR) bids for a Public Engagement Assistant post, and to support participation in national festivals.

6. Reports from Professional Services

The Group received reports from Student Services, and Research Services and Business Development. It was noted that support was needed to help staff make better grant applications, and that applicants were often unclear what was meant by the term 'public engagement'.

7. Reports from Student Union

The Group received reports from the Student Union President, and from the Chief Executive of the Student Union. Key points included the application to Sports England to support the provision of professional coaching qualifications in emerging sports, and the filming of six TED Talks at QMUL in June.

 - o Enhancing quality engagement and enterprise activity across the College;

 - Supporting development of staff through reward of engagement and enterprise skills
 - Ensuring integration of support across all aspects of the college, including professional services
- Developing appropriate high quality provision and support for measuring the impact of engagement and enterprise activities, ensuring such activities can contribute to college wide activities such as the REF
- Receiving updates on related Task and Finish Groups
- Receive reports on large Public Engagement and Student Enterprise projects, including Centre of the Cell and the Mile End Group, considering issues arising and seeking College-wide solutions to matters of concern
- Receiving updates on other significant related Public Engagement and Student Enterprise projects, such as People's Palace Projects
