Student Recruitment, 2016/17

As at 06 May 2016, recruitment figures were not as high as we would have hoped. Compared to last year, undergraduate figures are down for both home/EU and overseas. Postgraduate taught recruitment is down for home/EU, but that is offset by figures for overseas students.

The home/EU undergraduate application position is near-final (overseas applications can be received up until 30 June), as the UCAS acceptance deadline has passed. We are now proactively planning for confirmation and clearing in HSS and S&E, and are well-prepared for recruiting a good number of students through clearing. Central admissions has started preparation with faculties and schools. MRAG will oversee planning for and delivery of confirmation and clearing as usual.

There is still time for further recruitment to postgraduate taught programmes, as recruitment continues through the summer, and we anticipate further interest following the PG virtual open day on 11 May. QMUL Model

Grade Point Average (GPA)

The GPA task and finish group has been working towards recommendations for the introduction of a GPA alongside degree classification. A desk exercise of mapping between mark intervals, grades, and grade point averages has taken place for two schools' undergraduates and now for a postgraduate graduate programme from the Centre for Commercial Law Studies. A pilot will be undertaken in 2016/17 with the intention of full implementation of the GPA in 2017/18 to allow for consultation with schools and institutes.

Student Surveys

The National Student Survey has closed with an increased number and percentage of responses (2,112 students completing the survey, which is 70.1%). Thank you all who have helped promote the survey and communicate its importance to final year students. Results will be published in August. The Postgraduate Taught Experience Survey closes on 29 May.

Degree Apprenticeships

HEFCE recently announced a Degree Apprenticeships Development Fund (DADF) of £8m to encourage the creation of new degree apprenticeships. Phase 1 of the call (£3m), for HEFCE-funded institutions already active in degree apprenticeships, is to develop further degree apprenticeships for
