










Media Law (LAW6006) No. of responses = 18 (41.86%)






Medical Negligence Law (LAW6013) No. of responses = 15 (75%)




Performing the Law (LAW6060) No. of responses = 11 (73.33%)






Public International Law (LAW6032) No. of responses = 16 (44.44%)






Revenue Law (LAW6026) No. of responses = 19 (65.52%)






United Kingdom Human Rights Law (LAW6010) No. of responses = 15 (46.88%)
