Advising / pastoral support arrangements	-Very good stepping in of deputising Head of Dept, in the absence.	-General remark on the deficit of advising and pastoral support remarked due to staff illness. -1st Year: First year students still don't know what is going on with their year. A suggestion was made for more reassuring communication needed, especially at School and Departmental levels (e.g. what are we putting in place to mitigate the effects of the pandemic). The joint honours students also remark disparity between SLLF and, for example, School of History. -3rd: Similar disparity was noted with English informing what the School is doing to mitigate the pandemic. Also, there is a high level of anxiety regarding support available to students as to what to do after graduation.
