1. Summary

This report summarises the main areas of discussion of the Research Advisory Group to the Vice-Principal (Research) at the meeting held on 18 October 2018.

2. Terms of Reference and Membership

The Group reviewed its terms of reference and approved these for 2018-19 without amendment (excepting membership changes).

New members who have joined the Group this year are:

Deputy Vice-Principal for Research (Enterprise)

Deputy Vice-Principal for Research (Impact)

Dean for Life Sciences Initiative

The terms of reference and membership of the Research Advisory Group are annexed.

3. Knowledge Exchange Framework

The group received an update on the timeline and process for the KEF:

- Several briefing meetings have recently taken place with further ones scheduled for the near future.
- The proposed structure at present for KEF is in two parts, a predominantly metrics-based exercise and a Concordat.
- The Concordat is based on the model of the 'Concordat to support the career development of researchers'. The current draft has seven guiding principles and HEIs will be expected to undertake action planning to facilitate continuous improvement.
- For the KEF metrics analysis, the current proposal is to group institutions into clusters based on breadth of disciplinary subjects, staff FTE (proportions, T&R, R only, T only), student FTE, physical assets (capital spend), and research grant income (scaled by different factors).
- Initial modelling has produced five main 'clusters' of institutions (currently English institutions only). QMUL is provisionally included in a cluster with most of the long-established members of the Russell Group (Birmingham, Bristol, Cambridge, Imperial, Kings, Leeds, Liverpool, Manchester, Newcastle, Nottingham, Oxford, QMUL, Sheffield, Southampton, UCL, Warwick). The four Russell Group members that have not been placed in this group are LSE, Durham, Exeter and York).
- Data feeding into the metrics will be normalised for size and averaged across

three years to avoid 'lumpy data' skewing results. The role of the narrative statement is under discussion but current thinking is this will be a non-assessed element. There will be some focus on trajectory in the metrics rather than just absolute measures.

- The six areas currently suggested for KEF are:
 - Partnerships with the public and third sector
 - Partnerships with business
 - IP & commercialisation
 - Skills, enterprise and entrepreneurship
 - Local growth and regeneration (acknowledged may not be best measured through metrics)
 - Community and public engagement (acknowledged may not be best measured through metrics)
- The consultation on the metrics, including cluster methodology is expected to be launched in Nov/Dec. There will also be a consultation on the Concordat (coming shortly), and a review of HE-BCI metrics with consultation coming in 2019 (led by HESA).
- There will be no link between funding and KEF on the first iteration.

4. REF draft guidance and consultation

The Group were updated on the submission of the QMUL response to the to the REF consultation on the draft Guidance and Panel Criteria. This was formulated following consultation across the university and approval by QMSE. The final rules for the REF are expected to be announced early in 2019.

Feedback from the Group has been incorporated into the interim Queen Mary REF Code of Practice, which has now been circulated more generally to staff for comments. Following this consultation period, the Code will be updated and submitted to Senate in December. Once the final REF rules are known, the Code will be amended and approved as needed for submission to the national REF team by July 2019.

The Research Advisory Group shall receive regular reports from the Doctoral College Management Group.
- To consider research ideas and proposals raised through other research forums.
