# Reports

- 8. PB received reports from the Annual Programme Review and Periodic Review undertaken for the PG Law programme. This programme is jointly run by QMUL and UCL on behalf of UoL Worldwide. The outcomes and recommendations were discussed by the group and the following issues were noted to be raised with the academic committee with oversight for this programme:
  - Clarification of how the programme is addressing concerns raised by External Examiners on multiple occasions such as use of model answers, bunching of marks at 70 and challenging exam question structures
  - Confirmation that retention issues are being monitored and addressed
  - Monitoring of the variation in the number of awards being made year on year, including the recent decline and proportionally low level of distinctions awarded
  - Confirmation that the VLE is being reviewed to improve accessibility
  - Whether there are plans to expand teaching centres into other areas such as east Asia or Latin America

At its February meeting, PB received a response from the programme director at the University of London to confirm these points were being addressed.

### **Review of Partnerships Board**

- 9. At the 23 October 2018 meeting, Partnerships Board discussed the findings of the review of its structure and the partnership approvals process. The following outcomes were agreed
  - The triage structure would be implemented to streamline the partnership approval process and allow early identification of proposed partners that do not align with the Global Engagement Strategy.
  - The membership of Partnerships Board would be monitored and amended as required once the Global Engagement Executive was in full operation
  - Finance would be asked to provide a representative to attend Partnerships Board.
- 10. The implementation of the triage system has been effective in managing the number of partnership proposals that need to be considered by Partnerships Board. Therefore, at its meeting on 11 December, the group agreed that its meeting frequency would change from monthly to bi-monthly.

#### **Other Matters under Discussion**

- 11. Partnerships Board discussed other matters as follows:
  - Reviewing the use of fee-waivers to attract PhD funding
  - Monitoring, and discontinuing as necessary, partnerships that attract low numbers of students over time
  - Generating sufficient Study Abroad placements to meet the increased need for opportunities due to the expansion in the number of degrees with Year Abroad options
