## Education Quality and Standards Board Executive summary of the meeting held on 13 November 2019

- 1. The Board **noted** that Chair's action had been taken since the previous meeting to approve the following:
  - a. Admissions Policy on Student Immigration.
  - b. Admissions Policy for Students Under the Age of 18 Years
  - c. An exception to the English Language Policy for CONACYT-funded PhD applicants, to extend the period of recognition for their English language certification by three months.
- 2. The Board **noted** a written update from the Vice-Principal (Education), covering Education leadership and priorities, TEF, upcoming Education events, and Queen Mary's involvement in a European Universities Association (EUA) project exploring effective curriculum designs.
- 3. The Board **considered** extracts from the Strategic Risk Register relating to Education.
- 4. The Board **noted** an update from Christmas Vacation Student Support Task and Finish Group, including that the Library would be open from 0800-2000 throughout the vacation except on bank holidays to help students prepare for semester-based examinations.
- 5. The Board **agreed** that undergraduate CertHE and DipHE exit awards should in future be classified (pass/merit/distinction) rather than issued on a simple pass basis, in future. This will be included in the 2020/21 Academic Regulations for Senate's approval in June 2020.
- 6. The Board **noted** arrangements for a new programme review pilot, with a more heavily databased aspect that the current Annual Programme Review. Geography, Dentistry and Physics & Astronomy would participate in a pilot scheme in 2019/20.
- 7. The Board **noted** the 2018-19 summary report on suspensions of regulations. The Board was disappointed at the high number of cases, particularly where certain schools had a record of high numbers. It was hoped that the new programme review arrangements might aid in the reduction of cases. This report would also be considered by the Senate.
- 8. The Board **approved** a mark conversion scheme for Queen Mary students studying at Yale-NUS College in Singapore.
- 9. The Board **noted** the report of the 2019 Periodic Review of the School of Politics and International Relations, and the School's three-month update against the recommendations of the Review. The Board had no concerns and was satisfied with progress against the recommendations.

- 10. The Board **approved** 23 additional 'QM Extras' extracurricular activities that could be validated by Queen Mary for inclusion on students' HEAR transcripts.
- 11. The Board **noted** a written update from the QMSU Vice-President Education, addressing subject-level TEF submissions, student experience and learning resources, timetabling, course-representatives and elected officers, graduate employability, and sustainability.
- 12. The Board **considered** the report of the QMSU Student Experience Survey 2018-19, which had focused on the educational experience of black and minority ethnic students. The report made 13 recommendations for action. The Board agreed that QMSU would meet with the Vice-Principal Education and at a later point the Vice-Principal (People, Culture and Inclusion) to discuss these in more detail.
- 13. The Board **noted** the following quality assurance matters:
  - a. A new OIA good practise guide on fitness to practise.
  - b. A UUKi/GuildHE/QAA consultation on transnational education.
  - c. Queen Mary's Professional Statutory and Regulatory Bodies Register.
  - d. The final version of Queen Mary's annual assurance report to the Council.
  - e. High-level results from the UKES, PTES and PRES surveys, noting that further analysis was be conducted and considered later in the year.
