	2019-20 was an unusual year, and large numbers of suspensions were required to make rapid changes to module assessment schemes and other matters around programme design and delivery. The Covid-19 suspensions have been recorded separately, but the figures for this year should not be used as a benchmark against previous or future years – the Covid-19 suspensions will also have masked or removed the need for more usual suspensions where there were errors with assessment

Suspension of Regulations: Annual Summary Report 2020

Background

A report on suspensions of regulations is submitted annually to the Education Quality and Standards Board and to the Senate. Suspension may be requested where a situation arises in which the normal application of the Academic Regulations would either be manifestly unfair to one or more students, or where a situation has arisen that was not foreseen by the regulations (that is, where a change to the regulations is needed, but action is required on behalf of the current cohort). These cases should be extremely rare, and the situations leading to them are normally avoidable. In practice, numbers are high and Senate has repeatedly expressed concern regarding the number and nature of cases. Numbers had been gradually falling, but more than doubled between 2017 and 2018 and have remained high. 2019-20 is an exceptional year, as many suspensions were required to deal with the impact of the coronavirus; this has resulted in a large number of suspensions, but at the same time the need to make significant changes to modules and in some cases programmes will have removed the need for suspensions to deal with issues in the delivery of the original module design (which is normally the largest category of suspensions).


To obtain a suspension requires support from the appropriate Subject and Degree Examination Boards for assessment issues, or the Head of School/Institute/Directorate for other issues. Approval is given by the nominees of the President and Principal: the Academic Registrar (for taught programmes) or the Vice-Principal Research (for research programmes). All requests are passed through ARCS, and screened at that stage, so the vast majority of cases that reach the stage of a formal request are approved; those that would be rejected seldom reach the stage of formal consideration, following discussion with the proposers.

This report covers the period 1 October 2019 to 30 September 2020. Tables showing a breakdown of requests by faculty and school/institute are provided, and a brief summary of each suspension and its cause is given in the appendix.

Annual summary data 2018-19

Total numbers

Total numbers have increased, but 2019-20 data should not be used as a comparison as so many requests relate to the coronavirus (similarly, the spike in 2017-18 related to industrial action so it is difficult to make substantive findings). Normally, each instance of suspension is recorded individually; in 2019-20 mass suspensions were made, covering multiple modules. Most schools/institutes did this in one go, but some sent additional suspensions for changes that were missed, or where further changes were required, which also distorts the data this year.



Faculty numbers

Relative figures between the Faculties tend to remain broadly consistent year-on-year (partly due to the larger number of schools in H&SS and the greater level of flexibility in module selection), but there has been a sharper increase in S&E and SMD than in H&SS this year. However, this is not necessarily meaningful as all schools were forced to make suspensions in response to the impact of the coronavirus. Figures in brackets are 2018-19 totals.

School and institute numbers

There has been a shift in the relative numbers of cases from each school/institute, but as discussed above this is not meaningful in most cases. For example, the two schools with the highest numbers are SLLF and SEMS, which each had 14 cases. Ten of SLLF's cases related to mitigation of the impact of the coronavirus, whereas only three in SEMS related to the coronavirus – this inconsistency applies across Queen Mary, and the data should not be used to make judgements this year. Figures in brackets are 2018-19 totals.

Common themes and notable cases

Coronavirus

A large number of suspension requests (72 – 55 per cent of the total) were made to mitigate the impact of the coronavirus. These included changes to module assessment schemes to deliver assessments that could be conducted remotely (these accounted for the majority of cases), and in a much smaller number of cases changes to the delivery of programmes, including term dates, module availability, and practical arrangements. There was also one institutional-level suspension which confirmed the contingency arrangements for assessment, progression and award as derogations from the standard regulations. These suspensions were almost without exception unavoidable. Requests often related to multiple modules – these were logged for the purpose of this summary report as one case per request made, but Queen Mary holds the details of each individual change in the accompanying documentation for each change.

Assessment schemes

In 19 cases (15% of the total), suspension was requested to validate unapproved assessment schemes in cases unrelated to mitigation of the coronavirus (most of them relating to semester one). This is a perennial problem. In a typical case, a module organiser has formally communicated incorrect assessment details, conditions, or weightings to students, who have completed those assessments in good faith. It is therefore difficult to refuse approval, as students would otherwise be disadvantaged for a school/institute's error.

Explanations from schools and institutes have included that a module amendment was planned but never submitted, a module amendment was made but forgotten about, and – in many cases – the module organiser chose to deliver an alternative scheme without this being approved through the appropriate process.

Assessment schemes are designed to test particular learning outcomes in accordance with broader school/institute assessment strategies and national subject benchmarks. Making unapproved changes on an ad hoc basis can undermine that work. Queen Mary should be able to report with confidence on the accuracy of its assessment patterns, and this is an area that would benefit from review. It is very likely that a large number of additional suspensions of this type have been concealed or made redundant this year by the coronavirus suspensions – typically Queen Mary receives a significant number of these requests in May each year, when schools attempt to enter marks and find that the scheme delivered does not match the scheme approved (for which mark entry has been set-up).
