Outcome requested	Senate is asked to approve the Taught Programmes Board Terms of Reference and Membership for 2020/21. Senate is asked to note the following proposals relating to programme and module academic developments that have taken place between 1 st October and 4 th November 2020.
Executive Summary	 The attached report summarises the proposals considered under the Board's remit since the last report made to Senate. Several changes are proposed to the Board's Terms of Reference: The Board will have oversight of all taught provision (including non credit bearing provision such as CPD and Executive Education); the method of consideration of this provision will be at the discretion of the Board and may not require a full meeting (i.e. it could be considered by circulation or through a sub-group, in the interests of agility and proportionality). The Board will consider programme suspensions and withdrawals. The Board will meet more frequently in 2020/21; meetings have been scheduled on an approximately monthly basis for the remainder of the year. Several changes have also been made to the Board's Membership: To replace outgoing members, three new Faculty staff representatives have been nominated: Humanities & Social Sciences: Dr Michael McKinnie Science & Engineering: Dr Craig Agnor Medicine & Dentistry: Dr John Buchanan The Head of E-Learning has been made an ex-officio member of the Board. The three QMSU Faculty Vice-Presidents will act as the student representatives on the Board; with the option of inviting additional School representatives for specific items of business as deemed appropriate. Alison Pettigrew will serve as the QM Academy representative on the Board.

Taught Programmes Board

Terms of Reference 2020/21

Remit

The Taught Programmes Board has responsibility for oversight of all taught provision (including non-credit bearing provision), and has a specific remit for the consideration of new programme proposals (and associated modules), significant programme amendments and programme suspensions / withdrawals on behalf of Senate. The responsibilities of the Taught Programmes Board are as follows:

- 1. To ensure that there is full and consistent consideration of new programme proposals;
- 2. To ensure that the programme approval process is independent from the school/institute that is proposing the development;
- 3. To provide procedures that allow for the most efficient turnaround times, greater responsiveness and the most cost-effective use of QMUL's resources;
- 4. To recognise the contribution that can be made to the process by school/institute learning and teaching lead staff and committees.

Terms of reference

- 1. To consider the detailed academic proposal for new taught programmes of study and related modules (including those delivered through collaborative provision);
- 2. To consider new module proposals where these are related to a new programme of study, or are delivered through collaborative arrangements, work-based learning, study-abroad or distance learning;
- 3. To approve new taught programmes either with or without conditions;
- 4. To consider and approve proposals for significant amendments to programmes of studies;
- 5. To receive reports of module proposals and amendments to modules that have been approved by Teaching and Learning Committees and scrutinised by the Academic Registry and Council Secretariat.

Membership

- 1. The Deputy Vice Principal (Education Programmes) (Chair)
- 2. The Deans for Education
- 3. The Deputy Deans for Education
- 4. Two further members of academic staff from each faculty drawn from a pool of three, nominated by the Vice Principal and relevant Dean for Education
- 5. A member of the Queen Mary Academy nominated by the Head of the Queen Mary Academy
- 6. The three Faculty Vice-Presidents (Students' Union) and up to three nominated school representatives drawn from a pool of seven
- 7. Up to three co-opted members from the staff of Queen Mary to ensure the inclusion of appropriate expertise (e.g. e-learning, collaborative provision).

In attendance:

- 8. Members of the Academic Secretariat
- 9. Heads of School/Institute or Directors of Education and administrative staff proposing programmes from their areas.

Nominated Members of Academic Staff

- 1. The call for nominations shall be conducted by the Academic Secretary.
- 2. Nominations will be accepted during the second semester prior to the academic year in which an elected member's period of office shall be due to end.
- Where a casual vacancy arises because a nominated member ceases to be a member before his/her term of office expires, the member replacing him/her shall commence a new term of office of four years and be eligible for re-appointment in the same way as other members.
- 4. A member who does not attend four consecutive meetings shall be deemed to have resigned his/her membership.

Operation of the approval process

- 1. The Taught Programmes Board will meet at least once per month.
- 2. Academic Secretariat staff will issue a series of deadlines for the approval process. Proposals for new programmes should be received 3 weeks prior to the date of the meeting of the Board.

- 3. Academic Secretariat staff will manage the process of allocating proposals to meetings in accordance with deadlines, ensuring that full consideration of proposals takes place.
- 4. Academic Secretariat staff will scrutinise all documentation for completeness, adherence to required regulations and curriculum frameworks (e.g. QMACF, FHEQ), external support (where appropriate), support from the school/institute Teaching and Learning Committee, and support from the Planning and Accountability Review.
- 5. Academic Secretariat staff have the authority to reject proposals that are incomplete or do not adhere to the regulations/frameworks.
- 6. The relevant Head of School/Institute or Director of Education and the programme proponent will be invited to attend the meeting to discuss the proposal with the Taught Programmes Board.
- 7. The Taught Programmes Board will be facilitated by Academic Standards and Quality Officers, from the Academic Secretariat. Specific responsibility for areas of Queen Mary will be indicated on the ARCS website.
- 8. The Academic Standards and Quality Officers will make contact with Chairs of Teaching and Learning Committees to offer guidance on the completion of documentation for the approval process, together with information on the operation of the Taught Programmes Board.
- 9. The quorum for Taught Programmes Board shall be one third of the membership.
- 10. If a meeting of Taught Programmes Board is inquorate, the Chairman shall decide whether; a) the meeting shall be postponed and rearranged, or b) whether the meeting shall proceed, with all decisions made to be considered preliminary, until the agreement of the required number of members has been confirmed to effect the decisions as formal for the record.
