The Group is Chaired by the Vice-Principal (Education) and comprises sabbatical officers from the Students' Union, the Deans for Education from each faculty and relevant professional services staff. IASCG has met once during 2022-23 and discussed revised terms of reference. These updated terms of reference are attached for Senate's review.

Industrial Action Strategic Contingency Group

- 1. The Industrial Action Strategic Contingency Group (IASCG) met 20 times during the academic year 2021-22. The group had been re-established during a period of industrial action to mitigate the impact of the industrial action on the student experience and to assure academic quality and standards.
- 2. The Group was Chaired by the Vice-Principal (Education) and comprised sabbatical officers from the Students' Union, the Deans for Education from each faculty and relevant professional services staff.
- 3. The work of IASCG was informed by the Office for Students' Briefing Note: *Disruption to students caused by industrial action*; this guidance required institutions to ensure that normal processes and procedures for maintaining academic standards were followed. The IASCG ensured that any mitigations applied during the industrial action were applied selectively and on the condition that students had demonstrably achieved the learning outcomes, that academic standards were maintained and that the requirements of Professional, Statutory and Regulatory Bodies were met. The mitigations put in place to address the impact of the marking and assessment boycott for undergraduate students on modules affected by the dispute during May-August 2022 were as follows:
 - 26 additional staff were identified from discipline networks, engaged and inducted in line with practice in any normal year in cases where marking could not be reassigned to existing staff. Deadlines for the receipt of marks in SITS were extended to give staff additional time to complete quality assurance processes.
 - A local requirement for final-year dissertations to be double-marked was lifted, at the discretion of the Head of School, on the condition that an adequate sample of work was moderated to confirm the standard of the marking.
 - 141 marks across seven modules were calculated on a sub-set of the component assessments after receiving assurance from the relevant School or Institute that the students had already demonstrated achievement of the intended programme learning outcomes of the components that were completed.
 - Students were permitted to progress with missing marks in 30 credits, following a review of each individual student profile, provided that they had: taken the full 120 credits over the year; passed at least 60 credits in 2021-22; submitted at least half of the work, or had valid extenuating circumstances, in the modules with missing marks; met or were able to meet any programme specific requirements
- 4. IASCG met for the first time during the 2022-23 academic year on the 1st December. The Group discussed revisions to its terms of reference to ensure a clear focus on compliance with the ongoing conditions of registration with the Office for Students. The revised terms of reference are provided below for Senate's review.

Terms of reference

The Industrial Action Strategic Contingency Group is a standing group of Senate that convenes during periods of industrial action that will disrupt education. Its terms of reference are as follows.

- To monitor the impact of industrial action on education and take all reasonable steps within the scope of Senate and in liaison with Faculties, Schools and Institutes to avoid or limit disruption to students.
- To consider changes to assessment in this context, ensuring that students are not disadvantaged and standards are maintained, and make recommendations to the Chair of Senate on changes that require a temporary suspension of the Academic Regulations.
- To advise on communications with students to ensure they understand the impact that disruption will have on their studies and the steps being taken to mitigate the impact of any disruption.
- To report to Senate on its activities and action taken.
