# Summary of Academic Developments in the year 2023-24

In the academic year 2023/24, DGLS processed just over 2,000 academic developments. Of these Approximately 1000 of these were module amendments, the bulk of which were submitted between May and August. Most of these amendments were submitted by the July deadline.

During the year, DGLS processed 13 Part 1 Proposals, 29 Part 2 Proposals and 341 programme amendments (including programme title changes, suspensions and withdrawals).

This is a slightly higher number of academic developments than the previous year, where 1,900 academic developments were processed. There has been an increase in multiple amendments being submitted for the same modules/programmes within one academic year, which has impacted Queen Mary's ability to resolve amendments as quickly as would be desirable and, therefore, Taught Programmes Board is reconsidering more stringent guidance and would appreciate Senate's input.

## Comment on Academic Developments in the year 2023-24

Taught Programmes Board has noted the following areas that may benefit from review:

- 1. Awareness of the impact from making multiple amendments for the same modules/programmes within one academic year, which raises concerns over adequate strategy and planning.
- 2. Understanding of CMA concerns and implications where due process is not adhered to, including taking programmes to market without following standard programme approval compliance and deadlines.

Taught Programmes Board would welcome the Senate's views and support on strengthening the guidance for submitting programme proposals within the correct timeframes to follow the overall compliance with the University's academic development procedures, with the aim of reducing the number of programmes which receive late/exceptional approval outside of the standard processes.
