Education Quality and Standards Board 15 May 2024

The Board:

- 1. CONFIRMED the minutes and reviewed the actions of its previous meeting.
- 2. NOTED update reports from the Vice-Principal (Education) and the QMSU Vice-Presidents.
- 3. CONSIDERED and ENDORSED the following documents, recommending approval by the Senate.
 - a. Academic Regulations 2024-25, noting the minuted recommendations and amendments which would be made for the final draft before submission to Senate.
 - i. This included the addition of two new awards which were added to the University ordinances; the Master of Education (MEd) and the Clinical Doctorate (DClin).
 - b. Code of Practice for Research Degrees 2024-25, after having been reviewed by delegated authority to allow members time to read and comment on the paper due to late submission.
 - c. Assessment and Feedback Strategy 2024-25, noting the minuted recommendations and amendments which would be addressed for the final draft before submission to Senate.
 - d. Marking Policy, which was a new document but drew heavily from the 'Marks and Marking' chapter of the Assessment Handbook which it will replace, noting the recommendations and amendments minuted which would be addressed for the final draft before submission to Senate.
 - e. Assessment Handbook 2024-25, with no recommendations or amendments.
 - f. Academic Integrity & Misconduct Policy 2024-25, with no recommendations or amendments.
 - g. Student Complaints Policy 2024-25, with no recommendations or amendments.
 - h. Student Discipline Policy 2024-25, which was formerly the Code of Student Discipline, with no recommendations or amendments.
 - i. Professional Capability and Fitness to Practise Regulations, with no recommendations or amendments.
 - j. Student Voice Committee renaming (from Student-Staff Liaison Committee) and new Terms of Reference, ahead of the submission to Senate.
 - k. School/Institute Education Committee Terms of Reference updates for 2024-25, ahead of the submission to Senate.
- 4. NOTED a verbal update on the Appeals Policy review, which would usually be presented to EQSB, however the process had been recommended for review by the Community of Practice process improvement. The OIA would receive a report on the outcome of the review, which was well underway, and the updated Policy would be drafted for Senate.
- 5. NOTED the Register of Collaborative Provision for 2023-24, which was the central Register of all collaborative provision across Queen Mary and was used to track agreements, new collaborative business, updates on renewals and any expiring agreements.
- 6. NOTED the Register of Accredited Programmes 2023-24, which was the central Register of all accredited programmes across Queen Mary and functions as a log of evidence, tracker of accreditation/reaccreditation business, and expiring accreditation.
- 7. APPROVED the enforcement of the existing Policy for exams to apply also to online exams, which imposed the same deadline for quizzes and exam landing pages to be completed as is currently the case for paper-based exam papers, in order to reduce the risk of QMPlus crashing during an online exam.
- 8. APPROVED the use of Safe Exam browser as a viable and secure solution to deliver online and in-class exams in a way that would not allow open access to the internet.

Education Quality and Standards Board 16 July 2024

The Board:

- 1. CONFIRMED the minutes and reviewed the actions of its previous meeting.
- 2. NOTED update reports from the Vice-Principal (Education) and the QMSU Vice-Presidents.
- 3. CONSIDERED and ENDORSED the following documents, recommending approval by the Senate.
 - a. Admissions Policies for the 2025-26 academic year, noting the minuted recommendations and amendments which would be made for the final drafts before submission to Senate. The Policies received by the Board were:

 - b. Principles of Assessment Design, which had been written to complement the Principles for Academic Degree Programme Design and to support the Assessment Strategy. The Principles would be circulated to the Directors of Education (DoE) Forum prior to submission to Senate.
 - c. Updated Marking Policy 2024-25, which was considered and endorsed at the previous meeting of the EQSB but required further revision following feedback from SET.
- 4. APPROVED grade conversion scales for Humanities and Social Sciences programmes between China and Queen Mary, for publication on the Queen Mary website for students going on Study Abroad to Chinese partner universities in 2024-25.
- 5. APPROVED 2x new QM Extra activities, and 5x additional prizes. These would be recognised on students' records alongside their academic results.
- 6. NOTED the Student-Staff Liaison Committee annual reports for 2023-24 from the Faculty of Medicine and Dentistry, the Faculty of Humanities and Social Sciences and the Faculty of Science and Engineering.
- 7. NOTED a verbal report outlining the workstreams for the EQSB Assessment Sub-Board for 2024-25, which were identified as:
 - a. Extenuating Circumstances
 - b. Borderline Classification rule
 - c. Conduct of Assessment and Scaling
 - d. Exam Boards
 - e. External Examining
 - f. Retention of Assessed Work
 - g. Grade Conversions for international partners
 - h. Assessment Handbook
- 8. NOTED the new edition of the QAA Quality Code (June 2024) and the QAA Engagement Report for 2023-24.

Education Quality and Standards Board 18 September 2024

The Board:

- 1. CONFIRMED the minutes and reviewed the actions of its previous meeting.
- 2. NOTED update reports from the Vice-Principal (Education) and the QMSU Vice-Presidents.
- 3. CONSIDERED and ENDORSED the following documents, recommending approval by the Senate.
 - a. EQSB and Assessment Sub-Board business plans for 2024-25.
 - b.
- 4. APPROVED the Terms of Reference and Membership 2024-25, noting the required amendments and updates based on the minuted Board discussions. The final Terms of Reference would be sent to members for approval by circulation ahead of the November 2024 meeting.
 - a. The updated Terms of Reference would allow for the required regular reports to come to EQSB and receive the evaluation and scrutiny that was needed to keep the focus on quality and standards, greater oversight on alignment to the Office for Students, and bring in the work required for Ofsted for apprenticeship provision.
 - b. The updated Membership considered the recent review of academic governance which had taken place, which looked specifically at education and quality and standards to ensure alignment and focus across relevant areas. This had resulted in a sharper focus for EQSB.
- 5. NOTED concerns around the availability of modelling data for OfS Condition B3 and B4. This would be picked up off the back of the governance review where there was a focus on OfS Conditions of Registration alignment to ensure compliance.
- 6. NOTED the Programme Review Faculty reports from census point 1 of the new Programme Review process, noting the good work that had been taking place in certain areas this year.
 - a. Sufficient assurance across all of Queen Mary's taught programmes within the HSS and S&E faculties was provided.
 - b. FMD does not provide a summary of the Institute reports, any risk and good practice identified at programme level, and instead provides a top-down summary. This would need reworking once the individual Institute reports were re-submitted and approved by Faculty.
 - c. Schools/Institutes felt the new process was a positive experience, promoted good dialogue, and did not feel like a "box-ticking" exercise.
 - d. The focus in the census 1 reports on the alignment to the Principles of Programme Design provided a useful framework for Schools/Institutes consider when undertaking programme review.
- 7. NOTED the annual Queen Mary Academy Impact Report, noting the Academy's main priorities for the year to support the delivery of the Strategy 2030, and major areas of activity undertaken for the year.
- 8. APPROVED the CPD Framework for Educators, noting the need to evidence the professional development available to educators at Queen Mary, as required by the OfS and particularly Ofsted.
- 9. NOTED the Advance HE Engagement Report for the 2023-24 academic year, which provided an overview of how Queen Mary engaged with the areas of Advance HE, not only fellowship and accreditation but also the Race Equality Charter and Athena Swan.
- 10. NOTED a verbal report on the new processes for quality monitoring for Apprenticeship provision, including guidance, templates and a process timeline for programme and institute Self-Assessment

Reports (SAR) and Quality Improvement Plans (QIP). This was available on the Quality and Standards webpage on connect.

- a. The challenges with data accuracy, which was a recurring theme from last years Self-Assessment Reports, was noted. The new process timeline having data to be received by an October deadline would allow for quality checking and correction, if needed, prior to submission to Ofsted.
- 11. NOTED a verbal report on the name change of Module Evaluation Survey to Module Experience Survey. This was to further align the terminology to the wider student experience and the module as a whole, and particularly KPI 1 which had also incorporated the same terminology.
- 12. APPROVED the study abroad credit and mark conversions for American University (USA).
- 13. APPROVED 1x additional QM Extra activities and 24x additional Academic Prizes.
 - a. The large amount of new prizes as part of this proposal was considered, which also included 5 prizes to be read at graduation. This would create a new set of processes around each one and adds to the further proliferation of prizes.
