When you select continue, an email will be sent to the account used to create the application, you will need to verify the email to sign the declaration and pay the application.

If your identity can be verified through the UK Immigration ID check app you will be required to verify your identity by downloading the app in your smartphone, we recommend you read the guidance available or watch the Home office video to familiarise yourself with this process. When the visa is granted, your status will be digital and you will need to generate a share code to prove your rights

in the UK.

Please note, you will need to complete the identity verification first to be able to access the application form. If your identity cannot be verified through the app, the instructions to submit the biometrics will be outlined after making the payment of the application, in the <u>next steps</u>.

You'll be told how to book an appointment and upload your documents after you submit your application.

You do not need to send any physical documents to the Home Office or UK Visas & Immigration unless you are advised to do so.

Your application may be rejected if you do not provide all mandatory documents. If your application is rejected due to documents not being provided, it will not be considered and an administration fee for each person included in the application will be deducted from your refund.
